GENERAL RULES

- 1. This flower show conforms to the standards established by National Garden Clubs, Inc. (NGC), Handbook for Flower Shows, 2nd ed. (hereafter cited as HB), with any revisions published in The National Gardener (hereafter cited as TNG) (www.ngc.org); is the authority for all issues not covered by the Schedule, which is the law of the show. It is the responsibility of exhibitors to read it and the HB carefully. Flower show chairs are available to answer questions and for clarification.
- Entries are open to National Garden Club, Inc. members, students of Basic Floral Design Studies and Advanced Floral Design Classes, and invited guests.
- 3. Entry cards are available from Tallahassee Garden Club (TGC) Officers, Circle Chairs, Entries Chair, General Chair, and at TGC. Cards should be completed prior to entry of an exhibit (please use pencil). Address labels are permitted.
- 4. Staging and set-up will take place on the morning of Tuesday and Wednesday, April 25 &26.
- 5. There is an emphasis on fresh plant material. No artificial plant material is permitted in any exhibit in any division.
- 6. Exhibition of an exotic invasive plant as deemed by the University of Florida's Institute of Food and Agricultural Sciences (IFAS) Assessment of Non-Native Plants, is not permissible. This includes all divisions. Consult: http://assessment.ifas.ufl.edu/assessments/?zones=1028&types=25451,1080,1074,25453,24042,24208 for a list of exotic invasive plants in the North Florida area.
- 7. The Classification Chairs for each division check exhibits for conformity to the schedule prior to judging. Final determination for conformance is the judges' responsibility.
- 8. Exhibitors should mark exhibitors' property with exhibitors' name.
- 9. Neither TGC nor the flower show committee assumes liability for damage to or loss of an exhibitor's property or personal injury or illness but we strive to assure the safety of all items after arrival and placement as well as all attendees.

10. Exhibitor removes or arranges for the removal of exhibits (all divisions) promptly on Saturday April 29th.

Judging Guidelines

- 1. Judging begins Friday, April 28th at 1:15pm and only judges, clerks, show chair, judge's chair and classification chairs are in the exhibition areas during judging. NO EXCEPTIONS.
- 2. The General Chair and Classification Chairs for each division are available during judging for possible consultations.
- All accredited or student judges who judge in the horticulture division determine the Award of Horticultural Excellence (division award) winner, and only winners of sections are eligible for consideration of this award.
- 4. All accredited and student judges who judge in the design division determine the Award of Design Excellence (division award) winner, and only winners of sections are eligible for this award.
- 5. An accredited judge signs and dates an entry scoring 90 and above and top award winners.
- 6. An accredited judge initials design entry cards for all ribbon winning exhibits and for an exhibit not receiving a ribbon, to confirm judging of the exhibit.
- 7. An accredited judge writes comments on entry cards of design and botanical arts exhibits.
- 8. An accredited judge does not subdivide a class; but may request that Show and/or Classification Chair do so. The Horticulture Classification Committee Chair and General Show Chair are free to subdivide classes by color, form, size, cultivar, variety or other distinguishing characteristics.

- Accredited judges use the NGC Standard System of Awarding. HB p39.
- 2. Only one first place (blue) ribbon per class/subclass may be awarded. Must score 90 or above.
- 3. Only one second place (red) ribbon per class/subclass may be awarded. Must score 85 or above.
- 4. Only one third place (yellow) ribbon per class/subclass may be awarded. Must score 80 or above.
- 5. One or more honorable mention (white) ribbons as are merited. Must score 75 or above.
- 6. The decision of the judges is final.
- 7. Awards may be withheld if not merited.
- 8. Each designated section must consist of three (3) or more classes.

DIVISION I, HORTICULTURE AVAILABLE AWARDS HB pp 40-41

- AWARD OF HORTICULTURAL EXCELLENCE-Division Awardhighest scoring blue ribbon exhibit, correctly named in the entire division- a rosette of green, orange and blue ribbons.
- 2. AWARD OF MERIT-Section Award-highest scoring exhibits in Sections A, B, C, D-rosettes of orange ribbons.
- 3. ARBOREAL AWARD- Section Award-highest scoring exhibit in Section E-rosette of green ribbons.
- 4. GROWER'S CHOICE AWARD-Section Award-highest scoring exhibit in Section F-rosette of dark green ribbons

DIVISION II, DESIGN AVAILABLE AWARDS

HB pp 42-43

- 1. AWARD OF DESIGN EXCELLENCE-Division Award-highest scoring design in the division, Classes 1-6 only-rosette of gold ribbons and is the winner of the Cheryl Bartell Design Award-given by District III Flower Show Judges' Council.
- 2. DESIGNER'S CHOICE AWARD-Section Award-given to highest scoring exhibit in Section A-rosette of purple ribbons.
- 3. TABLE ARTISTRY AWARD-Section Award-given to highest scoring exhibit in Section B-rosette of burgundy ribbons.

DIVISION III, BOTANICAL ARTS AVAILABLE AWARDS HB PP 44-45

- 1. BOTANICAL ARTS HORTICULTURE AWARD-Section Award-highest scoring exhibit in Section A-rosette of light brown ribbons.
- 2. BOTANICAL ARTS ARTISTIC CRAFTS AWARD-Section Award-highest scoring exhibit in Section B-rosette of navy-blue ribbons.
- 3. BOTANICAL ARTS PHOTOGRAPHY AWARD-Section Award-highest scoring exhibit in Section C-rosette of Black and white ribbons.

DIVISION I
HORTICULTURE
THE NATURE OF THE BEAST
RULES

- 1. Open to any amateur gardener who is a member of an NGC affiliated club. Pre-registration of horticulture is not required.
- 2. The NGC Exhibit Policies are printed in the HB, chapter 6, p 55, exhibiting in the Horticulture Division.
- 3. The rules for a single species cut or container grown specimen are listed in the HB, Chapter 6, pp 58-509. Arboreal and troughs must be in the possession of the exhibitor for 6 months. All other horticulture in Division I must be in the possession of the exhibitor for 90 days.
- 4. In order to receive an NGC Top Exhibitor Award, the exhibitor must identify the entry by its binomial name or currently acceptable scientific designation, HB pp 53-54 & 57. Plant nomenclature can be found at www.plantsoftheworldonline.org. Common names may also be given.
- 5. Cut specimens will be exhibited in clear glass vases (with wedging if necessary) provided by the flower show committee.
- 6. Cut specimens foliage is not to below the water line. (Exception-gladiolus)
- 7. All entries should be show quality, well-groomed and if appropriate in a suitable clean pot.

- 8. Exhibitor may double pot, if inner pot is not visible and a decorative pot is acceptable. The use of moss to cover inner pot is prohibited.
- 9. Prior to entry exhibitor must write <u>in pencil</u> the correct botanical binomial on the entry card to be eligible for any top award, HB pp 53-55 & 57

- 10. The Classification Committee assists exhibitors in entry process, if necessary, and may sub-divide classes with Staging & Placement Committees.
- 11. To give potential exhibitors ideas of plants to enter, many plants are listed which may not have entries.
- 12. Entry tags are available in advance from Show, TGC officers, Entry and Circle Chairs and at the Tallahassee Garden Club.
- 13. If a plant is considered a flowering plant, it must be in bloom and exhibited as a flowering specimen. A foliage plant may flower but should be exhibited as a foliage plant if it is grown for its leaves or is currently without flower.
- 14. Specimens with a class designation may not be entered in "Any Other Worthy" class.
- 15. Plants on the state's endangered or conservation plant list must be grown by the exhibitor or collected in a legal manner and so identified.
- 16. Exhibition of exotic invasive plants, as deemed by the University of Florida's Institute of Food and Agricultural Sciences (IFAS) Assessment of Non-Native Plants, is not permitted.
- 17. For Scale of Points for Horticulture-see HB p129.
- 18. All horticulture blue ribbon winners scoring 95+ are eligible for the AWARD OF HOTICULTURAL EXCELLENCE
- 19. Exhibits are limited to 10 pounds and/or 8" in width.

17 DIVISION II DESIGN ANIMAL KINGDOM

Rules:

- 1. The NGC Exhibit Policies are printed in the *Handbook of Flower Shows*, 2017 Edition, Chapter 7, Exhibiting in the Design Division, NGC Policies and Guidelines.
- 2. Advance registration with the appropriate Design Section Consultant is required.
- 3. Some plant material must be used in every exhibit. This includes fresh and/or dried plant material. Plant material may not have been grown by the designer.

- 4. Entry cards will be prepared and placed in the designer's exhibit space. To educate the public, all plant material **must** be identified on a 3" x 5" card placed next to the entry card. Binomial name or currently acceptable scientific and/or common name are acceptable. The designer may include a brief interpretation of the design on the card.
- 5. Exhibits must conform to the stated description and limitations of the Design Type if one is specified for the class.
- 6. Design classes are limited to four entries each. A designer may enter multiple classes with the Design Division, but only one per class.
- 7. The exhibit entered in competition must be work of only one designer and that designer's name must appear on the entry card.
- 8. If the designer is unable to fulfill the assignment, it it the designer's responsibility to provide a substitute and advise

the Design Entries Chairman of their replacement.

- 9. If the designer is unavailable to transport and/or set up her/his completed design, a substitute person may enter the exhibit for the designer. The designer will still receive exhibiting credit.
- 10. A single flower or a container grown plant is not a "design".
- Landscapes, scenes, or anything representing an actual item of clothing, person, animal, etc., are not considered acceptable in the Design Division. These items are exhibited in the Botanical Arts Division.
- 12. Religious symbols used in a design must be displayed in a respectful manner.
- 13. No height limit unless otherwise stated.

- 14. All design exhibits are judged directly center-front at least three feet from the exhibit, unless stated otherwise in the schedule.
- Design exhibits must be approved for conformance by the Section Design Consultant <u>before</u> the designer leaves the show area.
- 16. The designer has the freedom to choose Traditional or Creative Style with any design listed unless restricted by the schedule.
- 17. For Scale of Points for the Design Division see HB p 130.
- 18. All Design blue ribbon winners scoring 95+ are eligible for the Award of Design Excellence.

PLANT MATERIALS IN THE DESIGN DIVISION

Unless prohibited by the schedule, law or specific requirements of a Design Top Exhibitor Award:

1. **PERMITTED:**

- a. Products manufactured from plant material whose natural state (leaves, branch, tree trunk, root, etc.,) has been so altered as to be given a new identity and a specific name such as rope, basket, mat, etc.
- b. Decorative wood- An all- inclusive term for most dried wood that includes weathered wood and/or polished or otherwise treated wood. Not permitted in Tricolor classes.
- c. Altering the exterior appearance of dried plant material.
- d. Using absorbing solutions such as glycerin, bleach, anti-freeze, etc. on fresh plant material to change the natural dried state.

- e. Contrived plant material- (a form constructed of fresh and/or dried plant material appearing as an obvious "fantasy flower, foliage, and or stem").
- f. Dried man-made constructed components retaining their recognizable character as plant material (and are not used as a container), such as grape vine forms, etc. are considered dried plant material.
- g. Living plants with roots attached, such as moss, Bromeliaceae family members or container grown specimens.
- n. Plants on the state native plant list, grown by the designer or obtained in a legal manner and so identified.
- i. Fresh plant material may be clipped, stripped, bent, or otherwise manipulated.
- j. Non-perishable food products and cut fruits or vegetables must be sealed to discourage insects, odors, and discoloration.

2. **NOT PERMITTED:**

- a. Painting, flocking, glittering, or dying of fresh plant material in any manner. (All other embellishments of fresh plant material are permitted.)
- b. Artificial flowers, foliage, fruits, and vegetables. (**Artificial** is defined as "Imitation", or a "copy", handcrafted or manufactured to represent and/or appear as real plant material).
- c. Silk, plastic or imitation plant material.
- d. Manufactured items simulating plant material (Examples-singing/speaking flowers, motorized flowers and metallic flowers and foliage, fountains featuring metal cattails and/or waterlilies).

e. Plants found on exotic invasive list.

NON-PLANT MATERIAL IN DESIGN DIVISION HB pgs. 80-81

Unless prohibited by the schedule, law, or specific requirements of a Design Top Exhibitor Award:

1. PERMITTED:

- a. Accessories (a subordinate object other than plant material) and featured objects (an object that is dominant in a design).
- b. Dinnerware, inspired in design by the form of a plant (flower, fruit, leaf, vegetable, etc.) created not to replace the actual plant material, but to serve as an interesting piece of dinnerware.
- c. Objects adding interest when permitted by federal, state and/or local regulations, such as feathers, antlers, coral, orns, starfish, sponges, sea fans, shells, nests or manufactured or

- a. American and other national flags.
- b. Living members of the animal kingdom and/or taxidermal representations.

- 3. Open to any member of NGC affiliate club who pre-registers with the Botanical Arts Entries Chair before April 27th.
- 4. The rules for Botanical Arts are printed in HB, chapter 11, pg 91-96.
- 5. An exhibit is the work of a single exhibitor.
- 6. If an exhibitor is unable to fulfill the entry assignment, it is the responsibility of the exhibitor to provide a substitute and to notify the Botanical Entries Chair of the substitution immediately.
- 7. Exhibitor must neatly and correctly identify all plant material on a plain 3" x 5" notecard.
- 8. Exhibition of invasive plants, as deemed by the University of Florida's Institute of Food and Agricultural Sciences (IFAS) is not permissible. This website is referenced in Rules for the Horticulture Division.
- 9. An exhibit consultant is available to answer an exhibitor's questions, interpret NGC policy, and provide schedule updates and explain requirements.

- 10. Botanical Arts Entries Chair clears all exhibits for Schedule and Handbook compliance.
- 11. The Scale of Points for judging Botanical Arts Horticulture, Artistic Crafts, and Photography are listed in HB, Chapter 14, pg 129-131.
